Terms

Definitions – The following terms are defined for purposes of the Advertising Agreement.  
 Sharpe Images responsibility – During the terms of this agreement Sharpe Images will:  
 Provide advertising on the stated site on the front of this agreement for the stated term. Maintain internet based site for the use of the users of that site on a 24/7 schedule.  
 Customer's Responsibility – During the terms of this agreement the Customer will provide to Sharpe Images a post ready Ad, unless otherwise provided as a separate service by Sharpe Images.  
 Pay all INVOICES within 10 days of issuance. The Customer shall pay all reasonable attorneys' fees incurred by Sharpe Images to collect any sum due hereunder and to enforce any of its right under this Agreement.  
 Pay any applicable tax now or hereafter assessed, levied, or imposed by any federal, state or local authority.  
 Term and Rate – The initial term of the Agreement shall be for three (3) months unless otherwise provided on the front of this Agreement. This agreement shall automatically be extended for successive three (3) month periods and/or conditions set forth on the front of this Agreement, unless either party gives at least thirty (30) days prior written notice of its intent to terminate. Sharpe Images may change the rate during any renewal term. First billing after renewal will reflect change in rate and payment of invoice shall be considered acceptance of the new contract rates. No refunds will be given if the contract is voided due to the limitations stated below, misuse, non-use of Equipment, or non payment.  
 Additional Charges – Below are charges for which the Customer will be responsible: Design of Ad work, Changing out Ad - 1 month purchased = 1 ad change out. Any additional change outs will be \$25 each. Photography or other pictorial for advertisements
